First, the program is only available to commercial customers (including agricultural, educational, nonprofit and government institutions) of Met-Ed, Penn Power and West Penn Power.

Second, the program can complement your existing PJM demand response portfolio.

That means that even if you're already involved with one or more of PJM's demand response programs, you can still take part in this demand response program and add another layer of revenue to your DR portfolio.

HOW THE PROGRAM WORKS

- CPower's team of experts collaborates with you to create a custom energy curtailment plan that adheres to your operational and business needs.
- CPower will notify you that an event will take place based on our forecasts.
- Day-ahead pricing and curtailment projections are used to estimate projected revenue.
- The CPower app helps manage and monitor your demand response participation.
- Your CPower team manages your settlements and sends you your earnings.

Participation Period	June 1 through September 30
Dispatch Criteria	Day Ahead forecast over 96% PJM Regional Transmission Organization summer peak demand
Event Notification	Electric Distribution Companies will use the 9:45 am forecast when determining whether the following day will be a demand response event
Event Days	All weekdays between June 1 and September 30 (excluding July 4 and Labor Day)
Event Duration	4 consecutive hours (Customers must schedule all 4 hours or none.)
Max Number of Events	6 events per summer
Min Number of Events	If no events, we will conduct a test event to evaluate customer capabilites
Performance Measurement	Avg. Megawatt hour (MWh) reduction per hour
Software Included	CPower app: Easy to use web-based platform


